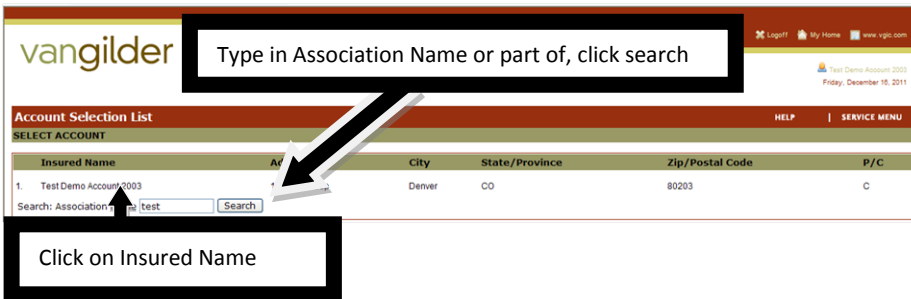
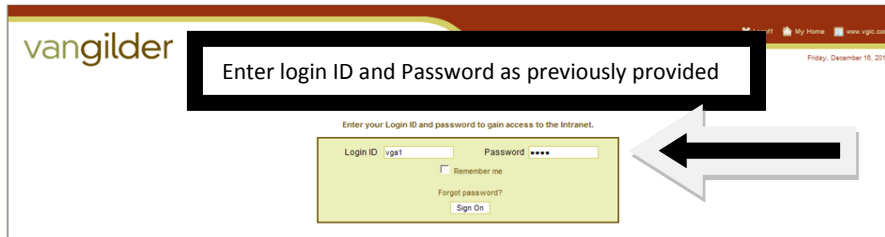


Community Association Certificate of Insurance

A Certificate of Insurance Request form will appear. Please enter the appropriate information for the Certificate Holder where indicated. Complete the Delivery Information. Under the Certificate Information, Description of Operations please include the property address, unit owner and loan number. When you submit the request, the information will be received in our office via email. A certificate will typically be issued and sent to you within 48 hours.
